2.3 Treasurer's report

The following comments were noted regarding the Financial Summary report as included in the AGM pack:

- This is for FYE2022, apologies for the lateness of this AGM, there are a number of reasons for this:
 - o Covid
 - Corrections needed in 2021 accounts resulting in late start of 2022 accounts.
 - Also there was a year of no treasurer, also adding to the delay.
- The processes in place are in great shape, thanks to the office staff for the work done here.
- The summary Report applies to RSCC Inc, Bethany Trust have their own accounts.
- Revenue was lower than in 2021, mostly due to a reduction in giving.
- Expenditure: refer to the report for details.
- Looking at the year ahead: budget year already completed, a budget was set with a deficit
 of \$100K, but over the past time this has been affected by inflation, increase cost of living
 and reduced giving.
- Important to note RSCC always have a contingency fund to manage any deficit.
- In recent times the Elders have highlighted toe strain on the financial situation in their communications to the church.

Consolidated Audit report as included in the AGM Pack: the following comments were noted:

- Qualifications requirements: these have always been quite difficult to audit they relate to activities in the church. Working on a better system for this in the future. Noted it is wonderful that as a church we have this many activities to report on.
- Comment regarding Bethany Trust in the space of loans received from within the church community: this is the same as previous year.

Looking at the year ahead: budget year has already gone, a budget was set with a deficit of \$100K, but over the past time this has been affected by inflation, increase cost of living and reduced giving. RSCC always have had a contingency fund to manage any deficit.

The floor was opened for any questions on the reports, none were raised.

2.4 Appointment of Auditor

- The Treasurer pointed out ongoing delays with the current auditors, influenced by factors such as COVID-19 and the absence of a treasurer for some of that time.
- FINNZ was re-appointed following delays in 2021, but additional delays occurred.
- A review was conducted, recognising some responsibility on our part, but also with the auditors, and feedback was provided both ways.
- A new auditor, Matley Audit Ltd, has been considered and is willing to take on the audit.

- The current audit needs to be completed as soon as possible, and FINNZ has indicated resource constraints.
- Proposal: Transfer the audit from FINNZ to Matley Audit Ltd, pending agreement from Bethany Trust.
- If Bethany Trust does not agree, FINNZ will continue as the auditors.

Consensus to to proceed with the move to Matley, subject to BT's approval. If not feasible, FINNZ will be retained - see decisions register.

General Business

3.1 General Business

Members were referred to the Proposed Updates to Constitution document - to be voted on at the AGM for financial year ending 2023.

- Items highlighted in yellow are areas of proposed changes, with text crossed out and/or text added in red.
- This has been a process that has been in the making for some time.
- We won't vote on this today, there will be a consultation period and then vote on the changes at our next AGM.
- Members were taken through the proposed changes, what would be removed and what would be added.
- This information is also available on the RSCC website.

Summary of the main changes:

- 3 month audit + AGM: unrealistic in the current environment. Suggestion this goes to the common one of 6 months.
- Item 8.0 The Board: Traditionally every other month there was a combined elders and Inc
 meeting, which takes up substantial time from our elders. There was also the desire to be
 able to pull in other skills and expertise. This change is to ensure elders maintain overall
 supervision and care, but also have a workable board to handle the day to day and provide
 governance in that space.
- Modernise the Rules and bring it up to date.

A general discussion arose and the following comments and questions were noted:

- Will this also include the update to the new legislation?
 - Explanation given that we have until 2026 to update to the new legislation.
 Explained there is some time for us to wait and see how the new legislation works in practice and that will assist with ensuring our Rules are updated correctly.
- Some relief was expressed it is not going to vote today as some further consultation needed, particularly with regards to section 8.

- Has good governance practice been considered, with a board of 15? Also, elders attending where necessary? Concerns there.
- The number of 15 is high, and it's unlikely it will get to this high number, but there
 needs to be provision for good external people (non elders) to come on the board
 and provide governance experience.
- o Concerns with elders coming in and out of the meeting this was acknowledged.

Noted that consultation provides option to put in written concerns and this can then be shared with the wider membership.

4. Other updates

4.1 Bethany Trust

Chair expressed gratitude for a separate trust looking after our buildings and our premises and their hard work in doing so.

4.2 RSCC Elders and Pastoral update

1.1 Introduction and prayer

Purpose of this Special General Meeting of Raleigh Street Christian Centre Incorporated Society:

- The purpose of this SGM is to ratify elders appointments since our previous eldership stepped down in July 2024, and to cover the agenda items as noted in this agenda.
- The selection and appointment process of elders is handled at eldership level, however
 under section 8.2 of the Rules 2011 of RSCC Incorporated Society (see attached to the

 of the Society.
- As noted under section 8.3, elders are automatically members of the Board once ratified. The Inc Board is tasked with governance of RSCC.
- Voting will take place by secret Ballot. Each member will have 1 vote on each elder.
- The Board will propose 3 scrutineers be selected to be approved by the Members present to count the votes on each ballot.

Alistair Brown in his capacity as Chair of this SGM requested confirmation from the board secretary that a quorum has been achieved. This was confirmed.

2. Ratifications and resignations

- Geoff Crawford and Cobus Kilian were appointed as interim elders by the eldership group that stood down back in July 2024.
- Their interim appointment expired once new elders were appointed.
- Voting to take place by secret ballot secretary to hand out ballot forms.
- Only Members of the Society are allowed to vote.

Chair explained the process of voting and motions.

• 2 groups of ratifications to the Board: Geoff Crawford and Cobus Kilian, and ratification of Jon Lee, Glen Brownlee and Gavin Pullenger.

An opportunity to speak was requested by John Waterhouse prior to the SGM. It was clarified by the Chair that he can only speak regarding the ratification process.

John Waterhouse spoke to the wider ratification process and the interest of informed choice, as well as the lack of transparency of the failing of the previous eldership. Significant concerns around the the mass resignation of the Elders in July 2024 and the process of new elders selection. The current process highlighted concerns around governance. As such, he asked for the existing process to be set aside and replaced with a more biblically grounded, transparent, and congregation-inclusive approach.

Chair thanked John Waterhouse for what he shared and asked if there were any others who wished to speak, again emphasising it needs to be purely with regards to the purpose of the SGM, being the ratification of elders appointments.

- As elders to date they have done 30 pastoral visits as well as various other meetings with staff and groups.
- Regarding future elder appointment: this policy is currently being revised at the moment. They are meeting every Monday and they noted they want a more rigorous process, not just for selection and appointment but as a leadership development progression. Once their proposal is finalised, it will come to the congregation for approval.
- This also applies to Deacons: they believe the role of a deacon is a biblical one, and the
 elders recognise we have people currently carrying out work of deacons but not being
 resourced or supported.
- Process to have assistance with communications that need to be shared, particularly in the more difficult areas.
- They are also working on church vision, defining this and then communicating what they believe God has planned for this place. Finding our values and who we are as a church.

Clarification was requested from one of the members around the required majority:

• It was clarified a majority was more than half of the votes to be in favour for a vote to pass. Chair has casting vote in case of an even vote.

What if not ratified?

Quorum for the board based on our constitution is 3 people with a majority of elders. If the
motions don't pass, the board will reconvene, and report back to the members. There will
likely be a recast of the vote to include proxy and absentee voting.

What is the vetting process for eldership, in particular to the theological vetting.

• It was clarified that all elders candidates were asked to go through the statement of faith and sign it. Important to note this was an unprecedented time for our church. As new elders they see the need for improvement of the eldership appointment process, more robust.

Finance update:

- Treasurer provided the members of the Incorporated Society with an update around the delay of the audit for Financial Year ending 2023 and 2024. Factors include:
 - knock-on effects from events of Covid and a correction that was needed at Bethany Trust level due to an error from the auditor.
 - Vacancy of the treasury role on the board with current treasurer moving back into this role as an interim measure.
 - o Change of auditors also a factor.
 - o 2023 audit nearing completion, by the end of the month. Then 2024 will then start.
- Recent years have been difficult with inflation resulting in significant cost increases, church giving down and a number of regular donations not received.
 - The current financial year is looking better.

o Permanent appointment of a treasurer needed and on the radar of the Board.

Update on work streams:

The newly ratified elders noted they are humbled by the support received today. They do not consider themselves great men, but believe they are called by God to this task. They have an audacious vision for RSCC and what it could be. Not diminishing the complexities of the issues at hand. Like the feeding of the 5000: we're not looking to human means here, but looking to God. To allow God to multiply us to show and have faith, that God will show up in the midst of this valley and guide us through. Mistakes are inevitable, but stay true to God's calling and his Word.

The Board has a number of actions and work streams underway. There are some complex matters to address, but we trust in God to help us get through. Reminded this is God's church and this is God's calling to the task. In 8 weeks they have been made aware of matters that do not sit well within a Christian Church setting. The board has appointed a group to prepare a scoping document for a Church health Check, for everyone to be able to speak into what is good at RSCC, but also what isn't and what needs to brought under God's grace and corrected. Scope to be approved this week, this will then go to 5 providers with quotes returned by end of this month, so these can be reviewed by the scoping committee and presented to the board.

Governance advice to address the question whether or not our current structure of Bethany Trust, Elders an Incorporated Society is the right structure for RSCC.

A team has been appointed to carry out a governance review, this also together with the requirements of Inc society updates needed with the new legislation that has come in. They will start meeting shortly to provide the scope for this important work.

RSCC Chair Report (FY2023-24)

This Chair's report covers two financial years: 1 April 2022 to 31 March 2023 and 1 April 2023 to 31 March 2024.

The financial year ending April 2023 was still very much feeling like it was immediately in the late-COVID-19 season, with the traffic light system in place for most of the year and restrictions slowly starting to ease from September 2022 onwards.

The 4.00pm service, which had been a response to the restrictions on gatherings that had been imposed by the government, continued with the blessing of the leadership. Other ministries that had taken a hit in terms of numbers attending – ICONZ and Girls Rally, for instance – were starting to regain numbers.

So, despite the challenges of the day, our many ministries continued to do the good work of bringing a taste of the Kingdom of Heaven to Cambridge. Some, like 24/7, expanded beyond what they had been doing before any of the lockdowns. This trend of slowly coming back to some normality post Covid continued over the 2024 financial year, and we are blessed our many ministries bounced back so well.

The Board is grateful to those many staff and volunteers who made week-to-week ministries (such as Youth Group, Amplify and Raleigh Street Kids, Mainly Music, ICONZ, Girls Rally, Playgroups etc) and one-off events (camps, the Light Party and Christmas services, for example) continue to happen.

Our thanks to the many members of the congregation who gave faithfully of their finances to help these many ministries continue. This is in the face of significant cost of living challenges. We recognise that it is a choice you make to support the work of RSCC. We do not take it for granted.

A range of charities and organisations also gave generously and partnered with us in our collective work. I would like to mention Cambridge Middle School, Cambridge High School, Longview Trust, Lichfield Trust, Jumble Around, Soul Purpose Trust, Trust Waikato, Cambridge Community Charitable Trust, COGS Waikato and WEL Energy Trust. Other organisations we have worked with include Waipā District Council, Fresh Choice, Mana Hapori and the MSD Capability and Resilience Fund.

The relationship with Bethany Trust is one that continues to be productive, and we thank those trustees for their faithful, diligent work in taking care of our facilities. The community beyond the Raleigh Street congregation continues to find these to be good quality, good value spaces to

pursue such diverse activities as performing arts recitals, funerals, a polling booth venue, school and sports clubs prizegivings, educational events and train enthusiasm. Long may these doors remain open to the community, just as gates of the New Jerusalem will be open day and night at the end of the age.

I would like to close by thanking the other members of the RSCC Inc board for their leadership and governance, both then and now, over the work here at RSCC, with a special mention to Geoff Crawford for undertaking the role of Acting Chair, and Alistair Brown for his service as both Chair and Treasurer.

Let us continue to eagerly seek to place Christ on the throne of our lives and to spur each other on to faith and good deeds, all the more as we see the Day approaching.

Financial year ended 31 March 2023

Treasurer's report

Today we will be reporting on the Financial results for the year ended 31 March 2023.

As we reported at the last SGM, we would like to again outline some of the delays in completing the audit of the financial statements.

Over the last few years, several factors have caused the delays in completing the audits on time including:

- The knock on effect of the delays from FY2021 and FY2022 when the Consolidated financials had to be amended following the auditors decision to change the disclosure requirements around the Land & Buildings in Bethany Trust (which has to be consolidated into RSCC)
- Time where there was a vacancy in both the Chair and the Treasurers roles on the Board
- The change of auditor to Matley Audit process took longer than anticipated

The audit of the financial year ended 31 March 2023 is complete and today will presenting those. The audit for FY24 is almost complete.

Year ended 31 March 2023

RSCC Inc (Raleigh Street Christian Centre Incorporated) is an Incorporated Society with a board and is the entity which employs church staff, enters into contracts when required for goods and services and enables the administrative requirements of the church. It also provides the legal structure for the activities of the 24-7 Youth Work in local schools.

BT (Bethany Trust) is a Registered Charitable Trust governed by a board of trustees (not the same as those of RSCC Inc). BT owns and leases out commercial and residential properties, including the land and buildings that the church operates from, together with most of the plant and equipment that the church uses (RSCC Inc is a BT tenant).

While the full financial statements are consolidated with Bethany Trust (the entity that owns the Land & buildings and other assets) we would like to mainly discuss RSCC today. Bethany Trust has its own AGM.

AUDIT REPORT

It is very pleasing to report this financial year RSCC has a clean unqualified audit report. This is testament to the financial controls in place.

There is however a comment in the audit report noted as "Emphasis of Matter – material uncertainty", relating to Bethany Trust receiving short term loans to purchasing Land & Buildings a few years ago and the uncertainty that exists around the ability to repay these in the ordinary course of business. Whilst this comment of uncertainty is noted, the audit report has not been qualified.



Today we will only comment on the RSCC figures in the financial performance for 31 March 2023, with comparison to the prior year (financial year ended 31 March 2022).

FINANCIAL PERFORMANCE 2023

Revenue for 2023 totalled \$873,379 (2022: \$927,445.) This was \$54,066 less than the 2022 year. This is mainly due to lower Offerings/Giving and other Donations which in total were \$97,662 less than 2022. On the positive the income related to 24/7 as well Other Income was up on the previous year.

Total expenses for 2023 were \$979,830 (2021: \$923,288) or \$56,542 (6%) more than the 2022 year. Some of this was driven by high inflation over that time of approximately 7%.

Expenditure included \$105,178 (2022: \$123,379) for 'Missions' (included in Grants & donations made). This includes overseas missions, support to long term missionaries and local missions.

Ministries expenditure of \$96,318 (2022: \$73,977) (shown below as Costs for goods & services provided) covers all expenditure incurred in providing programmes and events (includes Amplify, Children's ministry, Girls Rally, ICONZ, Mainly Music, Men's & Women's ministry, Youth).

The other main costs relate to our rent and administration and staff costs.

The net result was a deficit for the year of \$106,435 (2022: surplus of \$4,157), the reduction mainly as a result of lower Offering/Givings/Donations as explained above, at a time when inflation was driving up costs.

The tables in this report are only an overview of the Revenue & Expenses for the RSCC Inc entity for the period 1 April 2022 to 31 March 2023. Detailed information is available in the full audited Consolidated Performance Report.

THE YEAR AHEAD

At this time we would usually look at the next 12 months' budget, but as we already in 2025, we would like to outline the results for FY24 and FY25.

The unaudited results for FY24 and FY25 results show improved performance with increase in Revenue the major contributor.

FY24 still shows a deficit, however less than F23, of \$65,000, and FY25 a surplus of around \$10,000.

Bethany Trust - Chairman's Report

For the Year 1 April 2022 to 31 March 2023

Providing Inspiring Spaces that Bring People Closer to God

Bethany Trust exists to serve Raleigh Street Christian Centre and the wider Cambridge community by stewarding the spaces and facilities that enable ministry to flourish. Much of what we do is hands-on—maintaining buildings, improving infrastructure, and managing assets—but our work is always driven by our greater calling: creating places where people can encounter God and grow in faith.

This past year has been no exception. We have experienced God's provision, guidance, and blessing in countless ways, reminding us again of His faithfulness. For all of this, we give thanks.

Main activities

In June 2022, the tenants at 119 Shakespeare St vacated the property. Planning commenced to return the property to a marketable state, with a full interior repaint and a new bathroom required. Work began in February 2023, with CCCNZ expressing interest in the property in April 2023.

The residential properties at 22 and 16 Raleigh St were brought up to the Healthy Homes Standard.

Following the completion of refurbishment, Mana Hapori moved into 18 Raleigh St on 28 March 2022. The purchase and refurbishment of the property was made possible with the support of six investors, one of whom was RSCC Inc.

In May, the exterior of 18 Raleigh St, now named Bethany House was repainted by MMM and volunteers, saving the Trust approximately \$4,500. Waipa District Council issued the Code of Compliance for the earlier renovation work.

Work on updating the Trust Deed continued, aiming to align it with current legislation and reflect best practice. A Deed of Variation is being drafted.

At RSCC, heaters were installed in the concourse and acoustic panels were added to the café area.

Quarterly catch-ups with the RSCC Inc. Operations Team commenced in July, improving coordination on building matters.

Also in July, we began working closely with our neighbour to support the building of a new wing for the Medical Centre. This project got underway later in the year.

Planning for a Youth Lounge refurbishment started in August. This included addressing asbestos removal in the ceiling, which was completed in April 2023.

Several carpark safety improvements were carried out in November, including new footpaths, plastic bollards, and garden replanting. Wheel stops were added in March/April, and the carpark beside Rally Hall was designated for RSCC use only.

Additional improvements to the concourse included the installation of a reception desk and planter in November/December.

Sources of income

The trust continued to receive rental and lease income from the Medical Centre & WDHB car parks, Raleigh Street church complex, the houses at 16 & 22 Raleigh St, and the commercial lease on 119 Shakespeare St. The trust also brought the residential houses up to the Healthy Homes standard.

In addition to the rental income mentioned above, Bethany Trust also received gifts and donations.

Changes to the Board of Trustees

Kacha Vuletich and Clark Taylor joined the board in July 2022

Narelle Huggins resigned from the board, effective October 2022

Clark Taylor was appointed as Deputy Chair in December 2022

Rob Heebink took a 6-month sabbatical from March 2023 onwards

Bethany Trust continues to serve Raleigh Street Christian Centre and the wider Cambridge community by stewarding spaces and facilities that enable ministry to flourish. While much of our work is practical—maintaining buildings, improving infrastructure, and managing assets—it is always driven by our greater calling: creating places where people can encounter God and grow in faith. This year has been marked by progress and challenges, and we give thanks for God's provision and guidance throughout.

Main Activities

- Completed refurbishment of 119 Shakespeare Street and finalised CCCNZ tenancy, including structural and aesthetic upgrades (chimney removal, carpet, heat pump).
- Youth Lounge refurbishment completed (painting, carpet, asbestos removal).
- Sound system upgrade initiated with purchase of new console and multicore box; full upgrade budgeted for 2024/25.
- Cafe bar redesign and signage improvements progressed; chapel toilet upgrade planning advanced.
- Carpark safety enhancements completed (wheel stops, painting, bund installation).
- Medical Centre stormwater bund installed; easement legal review ongoing.
- Governance improvements implemented: BoardPro adoption, compliance policy development, Trust Deed variation lodged.
- Asset audit initiated for insurance and depreciation accuracy.

Financial Performance

Total Revenue: \$226,347 (up from \$193,843 in 2023), majority from commercial building & carpark leases and residential rentals, supplemented by donations

Total Expenses: \$270,372 (up from \$211,582), driven by higher maintenance and depreciation.

Deficit: \$44,026 (prior year: \$17,739)

Cash Position: \$171,985 at year-end (down from \$187,592)

Loans for 18 Raleigh St: \$500,000 interest-free, repayable on demand; \$100,000 repaid during the year; \$50,000 new loan received.

Net Assets: \$8.48 million (slightly down from \$8.53 million)

Governance Changes

- Clark Taylor appointed Chair (September 2023) following Rob Heebink's transition.
- Hilary Brown and Jason Masters joined as trustees in March 2024.
- Board agreed to remove mover/seconder requirement for motions to reflect collective responsibility.
- Auditor transitioned to Matley Audit for FY 2023 and FY2024.

Special thanks to RSCC Operations Team, Ken our RSCC maintenance person, and those involved in property maintenance and upgrades.
